**Dear Parent or Guardian,**

In the past there has been some confusion about the rules governing arrival and departure times at SYC events. The SYC rules state that once a person has arrived at the event, he or she should remain at the event until the end. That is for both their safety and our liability. This is why we hold car keys until the event is over.

Participants are expected to arrive at the specified time. In this busy world, sometimes there are events that come up that necessitate a late arrival or early departure, like a family wedding or mandatory sports event. However, we must be notified in advance and it must also be noted on the registration form if your teen will be coming late or leaving early. We must collect the full registration fee, even if your son or daughter does not attend the entire event.

If a participant does not send in or bring with them the proper signed forms, we do need to turn them away. Please discuss these rules with your son or daughter, and please feel free to address any questions you may have to any SYC/EC member or advisor.

## Rules and Regulations

All participants are expected to participate in the entire event. Once an individual has entered into our community, he/she will remain a member of our community until the end of the event. If you must leave early, please express that need to an advisor or Executive Committee member upon arrival.

2. Keys will be collected by an SYC advisor and will be secured for the duration of the event.
3. Alcohol, drugs, tobacco, weapons, fireworks, and pets are prohibited.
4. Anything of a sexual nature that you would feel embarrassed doing in front of your parents, or your pastor, is not allowed.
